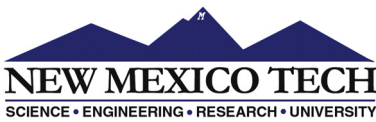

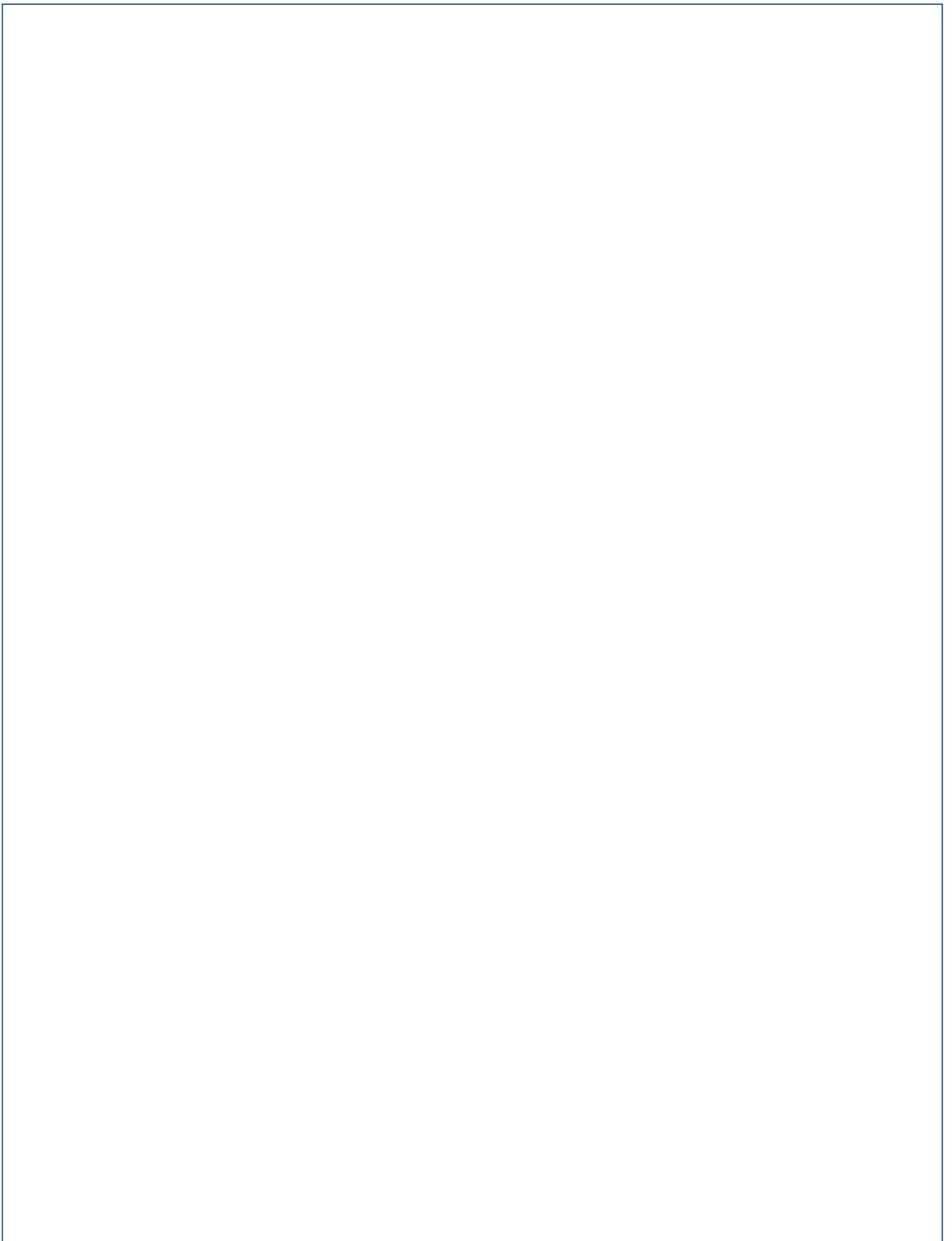

## CESTAC TELECON WITH COE CST EXECUTIVE COMMITTEE - WEDNESDAY, 16 APRIL 2014

Here are the summary notes and highlights from the call with Joe Rothenberg, Chair, CESTAC. The audio link is provided for your review.

The process we're using right now may not be the right process.

How and what would be useful from us from the CESTAC?

- **Dave Klaus (CU):** Might be too scattered as a center. Individual teams of one. Do more collaboration with industry to be less scattered.
- **Warren Ostergren (NMT):** Maybe reverse the way we're doing things. What if we engage CESTAC asking for their specific technical needs and shape our research to fit their needs.
- **Jay Kapat (UCF):** Each university may be able to reach out to their industry partners to bring them to the board.
- **Jim Vanderploeg (UTMB):** CESTAC's most valuable contribution could be to define the needs for the research. Ideas have come directly from FAA or UTMB but not so many ideas have come from industry. That may be because CESTAC participation has not been overwhelming.
- **Tarah Castleberry (UTMB):** No.
- **Carol Gregorek (OAT):** Pass
- **Fred Bowen (OAT):** Having a separate CESTAC meeting apart from tagging it onto the ATM or AAM. More informal presentations by PIs to industry groups. This would require funding.
- **Ken Davidian (FAA):** Public R&D and proprietary R&D are two different things.
- **Joe Rothenberg (CESTAC):** Research road map might be a way to bring new members to the CESTAC. Maybe it would be good to have interaction on front end to identify research requirements that industry might not be thinking about.
- **Joe Rothenberg (CESTAC):** If we came up with a strong road map that industry said they need and R&D community felt they were areas that industry recognized that were important, is it possible to take another swing at getting a bigger budget.
- **Joe Rothenberg (CESTAC):** Is it possible to put each research areas of the roadmap into the context of a specific industry activity that's real, that will help. Tie each research area and program to actual industry activities.

## APPENDIX A

### FAA CENTER OF EXCELLENCE (COE) FOR COMMERCIAL SPACE TRANSPORTATION

#### AFFILIATE MEMBERSHIP GUIDELINES

- 1.1** THE FAA CENTER OF EXCELLENCE (COE) FOR COMMERCIAL SPACE TRANSPORTATION OFFERS AFFILIATE MEMBERSHIP through the Federal Aviation Administration (FAA) Office of Commercial Space Transportation (AST). *(More information about the COE CST can be found on the web at [www.coe-cst.org](http://www.coe-cst.org)).*
- 1.2** To fully develop the network of organizations from academia and industry (including for-profit and non-profit organizations) with similar and complementary interests in the research conducted under the COE CST, the Executive Committee will consider organizations that wish to join the COE CST to conduct research as an Affiliate University Member or an Affiliate Industry Member.
- 1.3** An Affiliate University Member or Affiliate Industry Member (generally referred to as an Affiliate Member) is distinguished by bringing their own self-funded, unique research activities to the COE CST network.
- 1.4** Affiliate Members are defined as a public or private organization that conducts research or educational activities that fall within the COE CST research areas of interest. Educational organizations at the undergraduate level or above, including universities and colleges as well as community colleges, are considered eligible organizations.
- 1.5** Eligible organizations may be located within or outside the United States.
- 1.6** Affiliate Members are official members of the COE CST and are invited to participate in the COE CST annual technical meetings.
- 1.7** Affiliate Members are associated with the COE CST through a Host University.
- 1.8** A Host University is defined as one of the nine COE CST Member Universities that provides a rational and meaningful linkage between the COE CST and the Affiliate Member.
- 1.9** Affiliate Members become associated with the COE CST and may benefit from networking and collaborative activities of the center.
- 1.10** Affiliate Members do not receive direct funding from FAA AST. However, Affiliate Members research activities may be included in the COE CST annual technical meeting.
- 1.11** Once a Host University is identified and a candidate Affiliate Member accepted, the Host University and the Affiliate Member execute a Memorandum of Understanding (MOU) that defines the basic terms of the relationship.
  - 1.11.1** General Terms of the MOU are as follows:

- The Affiliate Member, the Host University and FAA AST will work together to develop a research task Statement of Work (SOW) that is satisfactory to all parties.
- There will be no exchange of funds among the Affiliate Member, the Host University and the FAA AST.
- The Affiliate Member will be responsible for all costs associated with the research being conducted and participation in COE CST meetings or activities.

**4.11.2** The COE CST will receive the following from the Affiliate Member:

- Timely submission of publicly-available results (products) of the Affiliate Member research activity in the form of papers and presentations given at meetings and conferences, journal articles, and any other publicly-available deliverables depending on the specific SOW. These products will be provided to the FAA COE CST Technical Monitor.
- Permission to refer to the Affiliate Member as such in its reports, executive summaries, and other instruments of information dissemination regarding COE CST-related research or activities.

**4.11.3** The Affiliate Member will receive the following from the COE CST:

- Official recognition of the Affiliate Member as such.
- Technical guidance upon request.
- A presentation opportunity at appropriate COE CST meetings.
- Permission for the Affiliate Member to refer to itself as such in reports, executive summaries and other instruments of information dissemination regarding COE CST-related research or activities
- Host university reserves the right to preapprove all papers and presentations given by the Affiliate to any and all professional meetings, congresses, symposia, journals, other publications, etc.

**4.11.4** The Affiliate Member will receive the following from the Host University:

- Sponsorship (non-fiscal) as an Affiliate Member into the COE CST through an executed agreement.

**4.11.5** The Host University will receive the following from the COE CST:

- Official recognition as a Host University of the Affiliate Member.

**4.11.6** The COE CST will require the following from the Host University:

- Entry of relevant data into the COE CST research task database (OMIS).

- Timely submission of required forms to account for matching funds provided by Affiliate Member.
- Timely fulfillment of annual reporting requirements associated with the research task performed by the Affiliate Member.

**4.11.7** The Host University will receive the following from the Affiliate Member:

- The value of all costs associated with the COE CST research being conducted by the Affiliate Member or its participation in COE CST meetings or activities to be credited toward the matching funds requirement of the Host University. The value of these costs may be carried to future years if not needed in the current fiscal year, if approved by the FAA COE Program Manager.

### **STRUCTURE AND OPERATIONAL BYLAWS**

#### **GOVERNANCE**

This document provides for the structure and operation of The Department of Transportation (DOT) Federal Aviation Administration (FAA) Center of Excellence (COE) for Commercial Space Transportation (CST).

This document lists the membership, requirements, structure, and privileges unifying the FAA COE CST and the nine core Universities. This organizational document is established to provide a formal mechanism that the FAA COE CST establishes to perform its mission of research into commercial space development.

#### **CENTER OF EXCELLENCE (COE) for COMMERCIAL SPACE TRANSPORTATION (CST) MEMBERSHIP**

##### **PREFACE**

The original nine core universities united under the overall FAA Center of Excellence Cooperative Agreements of the Federal Aviation Administration's Commercial Space Transportation Office, constitute the core membership.

The core membership of the COE CST at the time of ratification of this document shall consist of:

Herein after referred to "Executive Committee"

#### **I. PRIVILEGES TO WHICH MEMBERS OF THE COE CST ARE ENTITLED**

In recognition of their membership, research capabilities and interests, COE CST members are imbued with the following privileges that can be modified by the Executive Committee:

1. Membership in the COE CST is achieved upon ratification of this document by the original core universities.
2. All COE CST members will have immediate and unmodified privileges of the COE CST.

3. All membership will have access to, and publication of, research in all COE sponsored Publications and Research Capability Listings subject to peer review. (This privilege does not require any journal to accept member publications.)
4. All COE CST members and COE COE Affiliate members will be listed on the official COE CST Web Site and other publications.
5. In regard to Internet Web Pages, each member institution will be responsible for providing to the Executive Management Support Coordinator accurate descriptions and data regarding that institution's commercial space research capabilities.
6. The [www.coe-cst.org](http://www.coe-cst.org) web page is the responsibility of the Executive Management Support Coordinator.
7. Organizational publications. Each COE CST member and Affiliate member may list the COE CST in appropriate professional publications. The publications may cite the capabilities, accreditations and associations with other organizations related with that institution.
8. Business Cards. Business cards with the logo and notation that the represented institution is a COE CST member are allowed.

## **II. RESPONSIBILITIES:**

The primary responsibilities of the COE CST shall be to promote responsible research in the field of Commercial Space Operations and enhance the relationships among the FAA, University based researchers, and the Commercial Space community.

## **III. IDENTITY**

The organization is defined as the original nine core universities and the FAA COE CST. A broader organization may be formed made up of well-qualified entities who share a credible interest and expertise. These entities may be academic institutions, industry, or governmental/municipal institutions. It is expected that after a period of gaining experience with the role and contributions of these institutions the core organization can take advantage of other, well qualified associations. The Institutions that are not charter members of the COE CST may apply for Affiliate or Associate Institutional status at [www.coe-cst.org](http://www.coe-cst.org).

## **IV. ORGANIZATIONAL BY-LAWS OF THE FAA COE CST**

### **2. ARTICLE I: IDENTITY**

The COE CST is a duly approved entity of the FAA COE Program and consists of the original nine CORE members of the COE-CST and Items 1.1 – 1.4 below.

- 2.1 The original CORE membership consists of the original nine charter members contracted through an FAA Cooperative Agreement defining the relationships among the institutions and the FAA COE CST.
- 2.2 Affiliated Institutions with the privileges and under the conditions specified in this document.
- 2.3 The FAA COE CST
- 2.4 The Executive Management Support Coordinator.

**3. ARTICLE II: PURPOSE**

- 3.1 The COE CST members wish to contribute to the body of knowledge supporting the growth of Commercial Space Operations around the world.
- 3.2 The COE CST is formed to provide a formal means of coordinating members' research activities.
- 3.3 The COE CST By-Laws are the medium by which all members are permitted to voice their opinions and to participate in the administration of the FAA COE CST.

**5. ARTICLE IV: AFFILIATE MEMBERSHIP:**

Affiliate memberships in the COE CST are available to prospective institutions and organizations in accordance with the following general policy (*A detailed directive on the full qualification, selection and obligations of Affiliate Membership is contained in a separate document titled "The FAA CENTER OF EXCELLENCE FOR COMMERCIAL SPACE TRANSPORTATION ANNOUNCEMENT FOR AFFILIATE MEMBERS"*): Further information is found in Appendix A.

**6. ARTICLE V: RULES, REGULATIONS, AND REPORTING**

- 6.1 All COE CST members will abide by all rules and regulations associated with FAA directed activities.
- 6.2 All COE CST members will report their CST related activities on a quarterly basis. Such reports will be submitted in accordance with the rules and regulations approved by the FAA COE Program Office. The reports will be provided through the FAA approved management information system (OMIS).
- 6.3 An "End of Project" report will be submitted to the FAA COE CST Executive Management Support
- 6.4 Coordinator in accordance with the requirements set by the FAA (9550.5). Reporting will be through the OMIS.
- 6.5 All reports can be submitted to the COE CST membership for open publication unless such publication would be in violation of FAA COE CST rules.

**7. ARTICLE VI: OFFICERS, EXECUTIVE MANAGEMENT SUPPORT COORDINATOR, COMMITTEES, AND DUTIES**

**7.1** There shall be an Administrative Coordinator and Executive Management Support Coordinator. The Administrative Coordinator position will rotate annually. The rotation process will consist of an FAA call for participants.

**7.1.1** The Administrative Coordinator and the Executive Management Support Coordinator shall act as liaison team among the FAA COE CST, other Core Members and Affiliated members.

**7.1.2** The Administrative Coordinator will preside over all official meetings of the Center of Excellence for Commercial Space Transportation.

**7.1.3** The Administrative Coordinator and the Executive Management Support Coordinator will approve the final agendas of all official COE CST meetings and activities.

**7.2** The Administrative Coordinator if unable to serve a full term may have the position filled by appointment approved by the Executive Committee. If the position is prematurely assumed, the Administrative Coordinator will serve both the original Administrative Coordinator term and the one year that would have normally been the Administrative Coordinator's term. The Executive Management Support Coordinator will retain the administrative position and duties under the new Administrative Coordinator.

**7.2.1** The Administrative Coordinator and Executive Management Support Coordinator are jointly responsible for organizing and conducting COE meetings.

**7.2.1.1** The Administrative Coordinator team will develop the schedule of presentations for FAA approval.

**7.3** The Administrative Coordinator, the FAA, and the Executive Management Support Coordinator will manage the correspondence and financial affairs of the COE CST.

**7.3.1** The Administrative Coordinator and the Executive Management Support Coordinator will be the primary planners for any social activity associated with official COE CST meetings.

**7.4** All COE CST Principle Investigators (PI), Assistant Principle Investigators and Associate Principle Investigators are eligible candidates for all positions. All candidates must be legally affiliated with a COE CST Member institution or activity.

**7.5** Officers will be elected by a simple majority of the voting membership. A quorum of COE CST representatives must be present for the vote.

**7.6** The voting membership will consist of one representative from each of the COE Core Members.

**7.7** The Administrative Coordinator will assume their duties at the opening of the next Annual Administrative Meeting.

**8. ARTICLE VI: MEETINGS**

**8.1** The FAA COE Cooperative Agreements require a minimum of two meetings per year.

**8.1.1** Annual Administrative Meeting (AAM) – The AAM will be at a place and time determined by the COE CST Executive Committee. The AAM will be at a place and time determined by the COE CST Executive Committee. This

meeting will have a primary mission of reviewing COE policy, exchanging administrative concepts and managing the COE. The AAM will have a primary mission of reviewing COE CST policy and managing the COE Annual Technical Meeting (ATM)

**8.1.2** The ATM will have a primary mission of highlighting work accomplished during the past 12 months by the participating members.

7.1.4 Standing Committees: Self-Governance Subcommittee; Collaboration Subcommittee; and the Strategic Planning Committee. These subcommittees will report out at the AAM and ATM meetings. Informal briefings will be made monthly at the Executive Committee monthly teleconferences.

## **9. ARTICLE VIII: AMENDMENTS**

**9.1** These BY-LAWS may be amended by a majority vote of the core COE CST membership.

**9.2** The BY-LAWS were formally approved on \_\_\_\_\_ by signatures of the majority of the Core COE CST membership and the FAA CST representative.



**Background and Governance**

As one of the first tasks for the FAA Center of Excellence (CoE) for Commercial Space Transportation (CST), Stanford University Professor Scott Hubbard and graduate student Jonah Zimmerman completed a research roadmap for the CoE. This document was completed at the end of 2011 using the input of more than 100 representatives from various companies, organizations, universities, and government agencies who are present in the CST field. In the intervening time since the original research roadmap was completed, the CST landscape has changed and therefore the roadmap must be updated. This task will focus on updating the research roadmap and will be accomplished by the same Stanford University team, with the addition of Andrew Ow.

**Charter**

Our overall goal is to update the original research roadmap and build on it in order to increase its usefulness to the community and to the FAA CoE CST. There are three main components to our task:

1. Revisit the 2011 research roadmap and update as necessary
2. Identify and differentiate near term (1-5 years) and far term (5+ years) research tasks
3. Define research priorities to the extent possible

**Approach**

Our plan is to host five workshops focused on one or part of each of the research themes previously identified by the 2011 roadmap. Each workshop will be 1.5 - 2 days long. To reduce travel, we will host the workshops where the majority of researchers and stakeholders are located. Below is a list of workshops and suggested locations:

## Roadmap 2.0 Draft Planning Outline

- Planning for Roadmap 2.0 is underway.
- The Goals for this Roadmapping are:
  - After ~4 years of COE operation, revisit the existing research tasks, possible new directions and their place in a revised Roadmap.
  - Set the stage by asking the FAA to summarize what has emerged as priorities from a regulatory and licensing perspective.
  - Ask the current PIs for a given Theme what progress has been made and how they would characterize future work:
    - What is near term, medium term and long term research
  - Ask non-COE attendees how they would characterize future work:
    - What is near term, medium term and long term research
  - A critical objective is to get industry to say what is important to them
- In order to include all interested parties, yet minimize travel expenses we propose to make the discussion workshops for each Theme virtual.
  - The NASA Aeronautics Research Institute (NARI) will facilitate the virtual collaboration
  - We suggest an FAA HQs node using the LMCO Vision Center given the FAA video and teleconferencing firewalls.
- We plan 5 workshops, each going deeply into an element of the previous Roadmap.
- At present, we are planning for a total 1.5 days of content per workshop. Each workshop will occupy two days, about 6 hours each day to accommodate the 3-hour time difference for virtual attendees. For example, the workshop might be 8:00 am - 2:00 pm PDT, 11:00 am - 5:00 pm EDT. If the designated organizer PI finds more or less time is required, we can adjust as needed.
- The 5 meetings are:
  - Theme 1a (STM/ATM, plus orbital tasks - debris and autonomy):
    - PI Organizer: Juan Alonso
  - Theme 1b (Spaceports and related issues - suborbital) -
    - PI Organizer: Pat Hynes
  - Theme 2 (Ops Safety, Payloads and Safety, etc)

- PI Organizer: Farrukh Alvi
  - Theme 3 (Space Biomedicine and Human Rating)
    - PI Organizer: Jim Vanderploeg
  - Theme 4 (Industry Viability)
    - PI Organizer: Tristan Fiedler
- As indicated above, there will be a COE PI working on the Theme to serve as the domain expert organizer of each workshop. That PI will be responsible for:
  - Presentations about current work including other PIs working on the Theme
  - Including relevant and knowledgeable academic, government and industry participants who are not necessarily part of the current COE
  - Assisting in the documentation of the workshop
- A preliminary goal is to conduct the 5 meetings before the Holidays. For many schools that means by early December
- Taking notes and summarizing the output will be conducted by Jonah Zimmerman, Andrew Ow and myself
  - Presentation of draft Roadmap 2.0 nominally scheduled for early calendar 2015.
- The final report will be ready NLT May 31, 2015

**April 22, 2014**

The meeting was opened by Ken Davidian with welcomes from Pat Watts and Tristan Fiedler. For the next hour Ken discussed the CST funding and the likelihood of the CST continuation process for the next phase (five years). All participants expressed concern regarding the current funding level. It was agreed among the nine universities that if the funding level remained

constant they would rotate funded tasks with some schools receiving only travel funds and very restricted summer release time.

Patricia Watts discussed the Five Year Evaluation and its impact on the COE continuation process for Phase II. She reviewed the questionnaire, provided very high level feedback but no detail on the questionnaire since she had received the results only a few days prior and had not had the opportunity to assess the results. She is to provide the details at the ATM4 being held in Washington, DC on October 27-30, 2014. There were many questions from the schools on how to be more proactive and how best to help the FAA become more aware of the capabilities of the CST.

Tristan Fiedler, lead for the CST Collaboration Subcommittee, with members Pat Hynes, Warren Ostergren, and Jim Vanderploeg in attendance; provided an Affiliate Member Report showing the status of interested universities.

- Submit their proposal through the standard FAA proposal process using [grants.gov](http://grants.gov)

- Submit the appropriate budget (even if the budget is \$0)
- Submit Cash/In-Kind Match form (FAA COE In-Kind Cost Sharing) with supporting documentation from the Affiliate Member
- Upon acceptance, the task will be tracked in OMIS and the Affiliate Member will be setup as a “Primary Partner” permitting the OMIS to track the matching contributions
- Establish a method of receiving financial reports from the Affiliate Member that will satisfy the Host University auditor(s) and their State regulations
- Be responsible for entering the matching contributions in OMIS

Strategies on how to better engage the Affiliates and how strengthen the Affiliate/Host relationship resulted in the following suggestions:

- Include them in monthly Executive Committee telecons
- Fund Affiliates' travel to the annual technical conferences

Tristan Fiedler led the discussion on CESTAC relations. Industry needs to see a more immediate return on their involvement. The CST remains in its infancy thus long term relationships like those in general aviation and other long standing research areas haven't had time to coalesce. Outside the box thinking is required.

Former astronaut, Sam Durrance and FL Tech Provost Dwayne McCay delivered interesting lectures on their time in space and with NASA, respectively.

#### **April 23, 2014**

The Executive Committee held a closed session to discuss a draft letter to Patricia Watts regarding their concern over funding limitations and CST continuation.

Action: Juan Alonso is to draft and circulate to the Executive Committee for concurrence.

The Governance Committee report prepared by Nat Villaire was circulated prior to the AAM4. Comments were integrated into a revised document.

Action: All the universities are to revisit the document and have their comments back to Carol and/or Nat before the ATM4. Getting standardized operating protocols in place is an imperative of the second phase of CST.

The Strategic Planning subcommittee report was made by the lead, David Klaus. This committee has looked to the other two committees to help them in attaining the CST policy and goals. It is expected their work will be more forthcoming in the next phase.

The Research Roadmap activity is being led by Scott Hubbard. A brief presentation was made by Juan Alonso with more information being submitted in a report coming out shortly.

Fred Bowen provided an updated CST website demo and review.

Carol Gregorek discussed the administrative procedures for reporting the quarterly status narrative in OMIS, answered questions on cost share/matching, task closeout procedures and requirements, and the no cost extension conditions

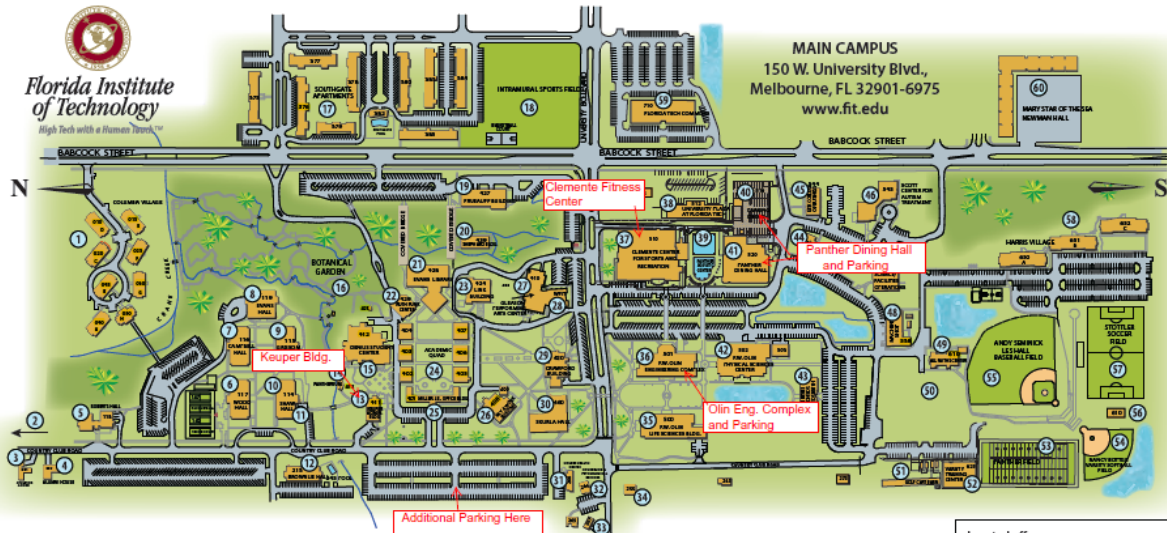
Dan Kirk gave a report on the research at FL Tech.

**October 28, 2014**

The fourth annual technical meeting began with a presentation by the FAA Administrator, Michael P. Huerta. The presentation honored UTMB for its work in Human Flight Research. Receiving the honor for UTMB were Tara Castleberry, M.D., and Charles Mathers, M.D. The research team leader, James Vanderploeg, M.D. was acknowledged. The presentation was held in the Bessie Coleman Room of FAA Headquarters. Mr. Huerta's address included the importance of commercial space transportation to the nation's economy, R&D, and its importance to the FAA.

The COE's are a national treasure who have provided and continue providing a talented well-trained new workforce. At the conclusion of the presentation the researchers, industry, and federal reconvened at the Hyatt Regency Capitol Room for the student poster session and discussion.

**October 29, 2014**

Professor Tristan Fiedler, the COE CST Administrative Leader, opened the meeting by welcoming the attendees and introducing dignitaries.

The keynote speaker, Melchor Antunano M.D., Director of FAA CAMI, began with remarks topics showing the emergence of medical research in the commercial space transportation industry. His address "Individual and Safety Survivability Considerations in Manned Commercial Space Flights" demonstrated the US leadership in CST.

Dr. Scott Hubbard chaired an R&D roundtable. The roundtable participants were industry leaders discussing industry near term and long term needs. The panel members were Ms. Debra Facktor-Lepore from Ball Aerospace, Dr. Alex MacDonald from NASA HQ Emerging Space Office, and Mr. Brian Barnett from SatWest.

Dr. Pat Watts gave a broad presentation discussing the COE program and the evaluation process for Phase II renewal. There were many questions after her talk where she agreed to an in-depth conversation at the presentation on October 30, 2014. Both her briefings are attached.

Ken Davidian provided comments and the FAA perspective on where the COE CST is in terms of its relevancy to the AST brain trust and the prospects for continuation for Phase II.

Dennis Filler, Director of the William J. Hughes Technical Center, furnished his comments during the lunch. He spoke of the superior work being done by the COE National Director, Dr. Pat Watts; the Tech Center's role in the FAA R&D; and his strong sponsorship of COE CST research thrusts.

Technical Research Area presentations were made by the Vehicle Technology and Industry Viability teams. See agenda for details.

Professor Tristan Fiedler adjourned the meeting at 5:30.

### **October 30, 2014**

Professor Tristan Fiedler opened the session at 8:00 AM with the first presentations being made by the Human Spaceflight Research team. These presentations were followed by the Space Traffic and Management Operations team.

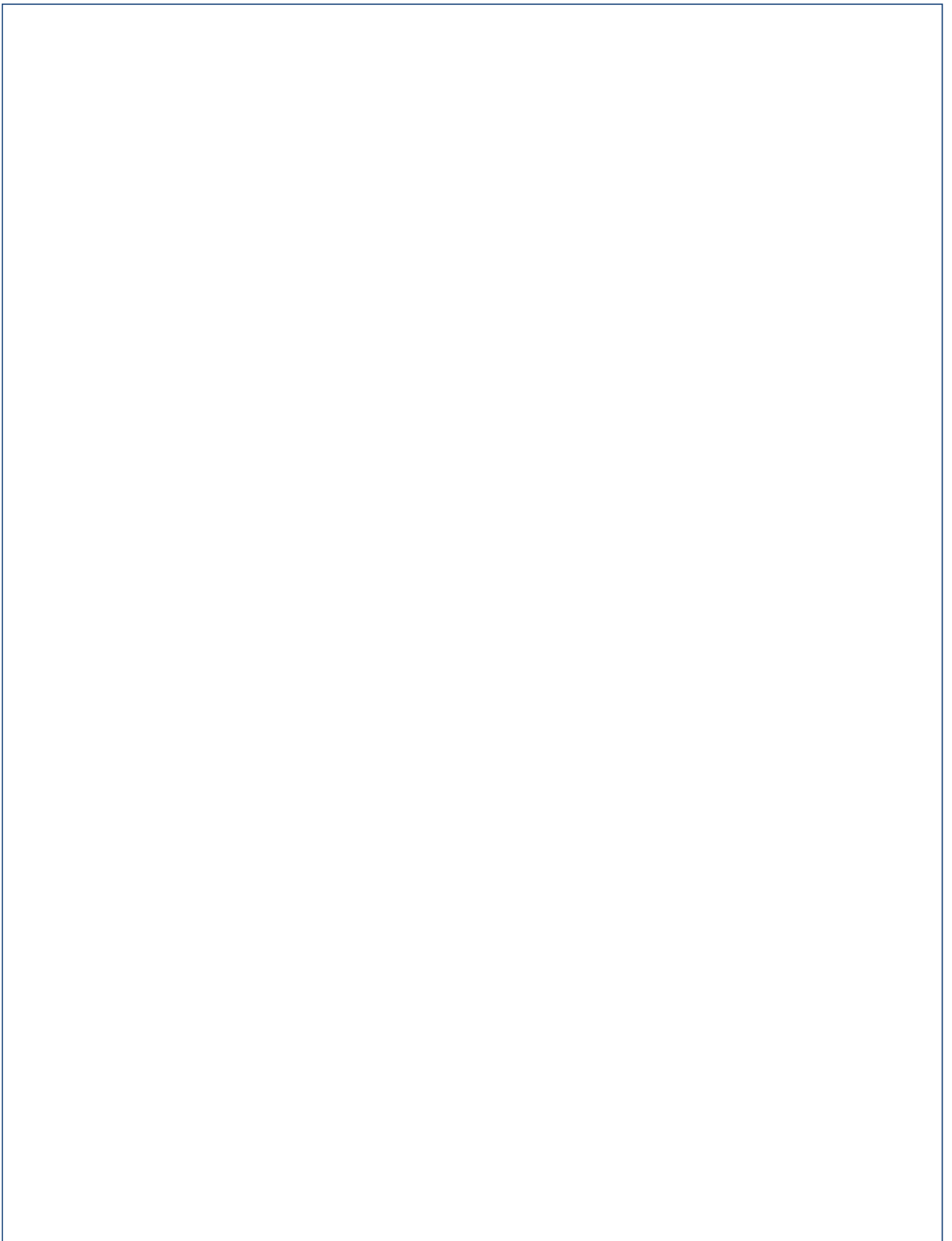

These key players are positioned to provide the industry with access to almost limitless materials and opportunities.

Concluding remarks detailing the results of the CST Phase I closeout survey were provided by Dr. Patricia Watts. The primary concerns were funding level, FAA AST acknowledgment and use of the CST research capabilities, and the standardized reporting for the COE versus the reporting of ordinary research grants and contracts. Dr. Watts discussed "turning on" the contracts piece of the COE legislation. This provides a mechanism for additional research funding.

Ken Davidian presented student banner awards to the top three winners. Judging was done by the FAA technical monitors and other technical attendees not associated with the universities.

Dr. George Nield, FAA AST Associate Administrator provided the concluding keynote statements. Dr. Nield has shared for the past five years his wisdom and deep knowledge of commercialization of space transportation. His unwavering sponsorship of the COE, his strong financial backing, and personnel support show his unflinching commitment. The COE CST owes a heavy debt of gratitude to him.

Concluding remarks were made by Ken Davidian thanking the contributors. He adjourned the meeting at 5:15 pm.
